THE PROPOSED CHANGES TO THE AJCA BY-LAWS ARE REGARDING ARTICLE XII. THE PRESIDENT, OFFICERS, AND EXECUTIVE BOARD FEEL THIS IS AN IMPORTANT ADDITION TO THE BY-LAWS THAT IS NEEDED TO DEAL WITH URGENT ISSUES OR CRISIS THAT MAY ARISE. THERE IS ALSO THE REAL POSSIBILITY THAT THE NEW INTER STATE COMPACT FOR JUVENILES WILL BE PASSED BY 35 STATES BEFORE THE NEXT ANNUAL MEETING AND THE OFFICERS AND EXECUTIVE BOARD MAY HAVE TO DEAL WITH SOME OF ITS MEMBER SHIP NO LONGER BEING ABLE TO REMAIN IN THESE POSITIONS AND THIS CHANGE TO THE BY-LAWS CAN BE USED TO ADDRESS THIS SITUATION IF AND WHEN IT ARISES. ATTACHED IS THE PROPOSED ADDITION TO ARTICLE XII.

URGENT BUSINESS AND ALSO TO PREPARE
FOR THE TRANSITION TO THE NEW COMPACT.
